### **REGISTRATION AND IMPORT OF COSMETIC PRODUCTS FOR CHINA MADE EASY**

Our China Import Program helps organizations introduce cosmetic products to the Chinese market and meet the applicable rules and regulations.

New measures issued by the National Medical Products Administration (NMPA) came into effect on May 1, 2021. Although the recent regulations make importing to China easier for global cosmetics brands, the procedure is still complex and involves multiple processes and sub-processes.

#### LATEST COSMETICS DEFINITIONS

The latest regulations introduce key changes to what is considered to be a cosmetic product in China.

In China, cosmetic products are defined as chemical products in daily use, intended to be applied on the external part of the human body (such as skin, hair, nails, lips, etc.) by spreading, spraying, or other similar methods for cleansing, protecting, beautifying, or grooming purposes.

The NMPA has identified two classifications for cosmetic products:

#### SPECIAL COSMETIC PRODUCTS

Cosmetics with a special purpose or function, are divided into six categories:

- 1. Whitening/anti-spot
- 2. Sunscreen
- 3. Hair dye
- 4. Hair perm
- 5. Anti-hair loss
- 6. New function (as determined by NMPA)

#### **GENERAL COSMETIC PRODUCTS**


All other cosmetics that are not considered special cosmetic products.

#### PRODUCTS NO LONGER CLASSIFIED AS COSMETICS

- 1. Toothpaste (has separate supervision and administration regulations)
- Soaps (are considered cosmetics but are not required to have record-filing unless they have special cosmetic claims)
- 3. Other oral care products

# THE NEW PROCESS

With the new regulations set by the NMPA, special products follow a stricter procedure for notification and registration:
