China is one of the world's leading countries for 5G development. The concept of smart homes and smart cities has led consumers and governments to look for innovative products on the market.

For the consumer electrical and electronic (EE) market in China, there is keen competition between international and local brands. Smart and innovative features are essential for new products.

When overseas EE brands plan to promote new smart devices to the Chinese market, we can help them to apply for the necessary compliance test reports and certifications (e.g. China Compulsory Certification (CCC), Wireless and China Chemical requirements). SGS also has a wide range of services, in addition to regulatory requirements, including cybersecurity, connectivity testing and product performance testing, which can help you differentiate your products from your competitors.

CCC

China Compulsory Certification (CCC) is a mandatory certification program for 17 types of EE product, as listed in the product catalog. Listed products need to comply with national standards and technical specifications to obtain CCC certificates.

Note: Products that are not listed in the product catalog do not require certification but can be randomly inspected by State Administration for Market Regulation (SAMR – the official administrator of the CCC) to show compliance to relevant national standards and technical specifications. SGS's CCC scopes include but are not limited to:

- Active single or multiple speaker systems
- Audio power amplifiers
- Power supplies
- Built-in power supplies for computers or servers
- Appliances for skincare or haircare
- Electrical appliances for heating liquid
- Electric fans

- Electrical food processors
- Ovens (grills, toasters and similar portable cooking appliances)
- Rice cookers
- Calculators
- Monitors/printers connected with calculators
- Scanners and printers
- Adaptors for IT products
- Servers
- Cash registers

CHINA ROHS

The Measures for the Administration of the Restricted Use of the Hazardous Substances Contained in Electrical and Electronic Products (EEP) was issued by the Ministry of Industry and Information Technology (MIIT) on January 21, 2016.

All electronic equipment and supporting products rated with a working voltage of not more than 1,500 volts measured in direct current, or not more than 1,000 volts measured in alternating current, need to comply with the China RoHS regulatory requirements.

PRODUCT COMPLIANCE

- CCC testing and certification mandatory safety certification for listed products
- Chemical testing including Chinese RoHS, food contact material testing
- Wireless and electromagnetic compatibility (EMC) testing – wireless testing is applicable to products with radio frequency (RF) functions such as Wi-Fi, Bluetooth, QI etc.) while EMC testing is required for all EE products

PRODUCT WITH SMART FEATURES

- Connectivity to mobile device/ cloud/APP checks – a functional check for products which have wireless modules that can connect with other devices via Wi-Fi, Bluetooth, NFC etc.
- Cybersecurity checks security level checking on data transfer and storage for products with data transmission functions
- Performance testing and certification

- Technical Factory Audit verification of production ability and production system of factories
- Advance Field Service the monitoring and control of inventory, production, component list and product construction check during mass production
- Inspection product inspection during the mass production or final random inspection according to acceptable quality limit (AQL) standard
